The company was created to expand its operational capacity into agency services, product access, renewable energy solutions, logistics coordination, procurement support and community-based business engagements.



BUSINESS MODEL

JCI positions itself as a platform that connects opportunities, service and participation, enabling individuals to contribute value through representation, partnership and access point engagements.

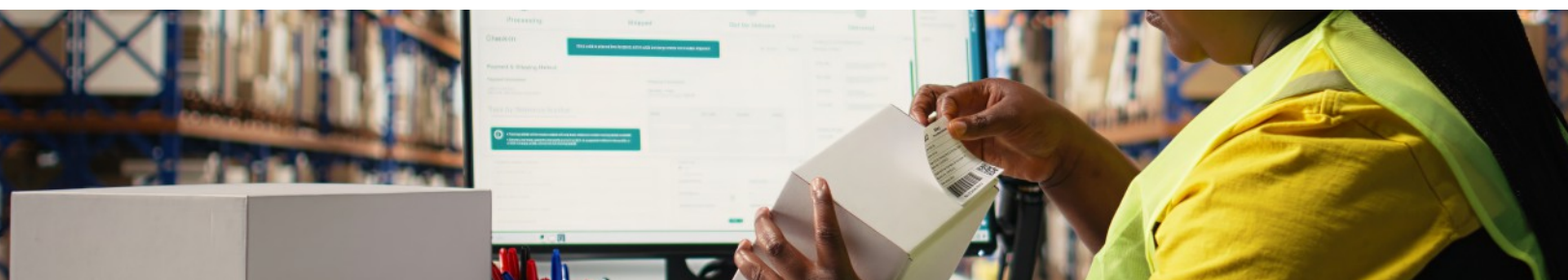
In this model, business is not limited to physical office structures but extended through trusted partners and community-based coordinators who support service delivery and market access.

COMPANY STRUCTURE

TRIUMVIR MODEL

The organization operates under a structured governance system known as the Triumvir Model, which is composed of three functional arms: Viceroy, Jury and Army. Each arm plays a distinct role in ensuring order, decision making, participation and overall business coordination.

VICEROY (SERVANT LEADER)

The Viceroy is the male servant leader responsible for the overall supervision and coordination of the business. He oversees the daily operations, ensures that activities are properly aligned with the organization's objectives, and maintains smooth and efficient functioning of the system.

The Viceroy also serves as the final decision-making authority in cases where resolution is required, ensuring stability, direction and accountability within the organization.

JURY (STRATEGIC ADVISORY COUNCIL)

The Jury is a selected group of male professionals drawn from different fields of human endeavor. This body serves as a strategic advisory council that meets periodically to generate ideas, identify opportunities and provide solutions that support the growth and advancement of the organization.

The Jury also plays a role in reviewing challenges, offering professional insight and recommending strategic directions when necessary. However, final decisions remain under the authority of the Viceroy.

ARMY (COMMUNITY AND WORKFORCE STRUCTURE)

The Army, also referred to as the Host, represents the wider body of members, partners and participants within the organization. It consists of men, women and young people from different backgrounds, nations and communities who contribute to the operational strength of the business.

Their responsibilities include carrying out assigned duties diligently, supporting organizational activities and participating in leadership selection through majority-based voting processes. The Army represents the foundation of participation, engagement and expansion within the organization.
